BOARD MEETING MINUTES OF THE

At 6:30 PM Mr. Samuel E. Norris, III offered grace before the meal was served to the Board.

President Hugh C. Shull called the SCNA Board of Governors to order at 7:24 PM. Excused from the Board meeting were Mr. Wendell R. Brush, Mr. James Vernon Epps and Mr. James T. Few. Jackson M. Zorn was absent.

President Shull called on the Secretary for the reading of the November 1, 1997, and the November 2, 1997, Board meeting minutes. Samuel E. Norris, III moved that the minutes be approved as published by the Secretary. The motion was seconded by Mr. Austin M Sheheen, Jr. and approved by the Board.
