

**GENERAL MEMBERSHIP MEETING MINUTES
OF THE
SOUTH CAROLINA NUMISMATIC ASSOCIATION**

October 26, 2002

Crowne Plaza Greenville, SC

The General Membership meeting was called to order by President Chibbaro at 9:32 AM. Mr. Edwin D. Wood gave the invocation.

Mr. Austin M. Sheheen, Jr., General Convention Chairman reported a quorum of members present.

President Chibbaro welcomed all the members to the 30th Annual Convention. He also welcomed Mr. John Wilson, ANA President. Mr. Wilson congratulated the SCNA for its 30 years and its support of the ANA. He thanked the SCNA for inviting him to the convention.

The minutes of the 2001 General Membership meeting were approved on motion Jim Barry that was seconded by Mr. John D. Kelly, Jr.

Secretary Brock reviewed the current membership status. It was noted the SCNA has 6 Life Member Clubs plus 2 additional regular member clubs.

Treasurer, Mr. Austin M. Sheheen, Jr. reported on SCNA financial status. Mr. Sheheen reported that a full financial report was made to the Board in August and that a full financial report will appear in the January Scanner.

Bourse Chairman, Mr. Samuel E. Norris, III, reported all show tables were sold but was unable to obtain a supply dealer. Mr. Gar Travis said he knew a supply dealer who might be interested for next year's show.

President Chibbaro asked if the membership had questions for the Board. Mr. Barry questioned why 3 Young Numismatist applications are required before a scholarship is awarded. Mr. Barry stated that the SCNA is probably missing some outstanding applicants with this restriction. It was decided that this would be reviewed at the next Board meeting.

President Chibbaro announced that Mr. LoRan Ross, Mr. Edwin Wood and Ms Amanda Sheheen had been elected to the Board for 2003-2004.

President Chibbaro announced the ANA Midwinter show scheduled for March 2003 in Charlotte, NC. He said he hoped SCNA members would support the show. Mr. Travis reported there will be a big Boy Scout program during the show.

It was announced that no morning worship would be held before the Awards Breakfast because a speaker could not be obtained.

President Chibbaro congratulated out-going Editor Ms Blendell I. Brush on the SCanner's 3rd Place Award for Regional Organizations by the ANA. He thanked Ms. Brush her for work as Editor of the SCanner. He then introduced Ms Helen Barry the new SCanner Editor. President Chibbaro also noted that the Board had cut the SCanner to 2 issues per year due to cost. In 2003 the cover will be changed and it is hoped this change will save enough money so we can go back to 3 issues per year.

The General Membership Meeting adjourned at 9:55 AM on a motion by LoRan Ross which was seconded by Mr. Hugh Shull.
