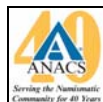

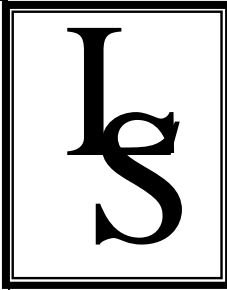

Any coin from the Denver mint proved to be almost impossible to locate. Although the Mints produce billions of coins it appears most of the coins do not circulate from where they were distributed or are being held by the public and/or government. If any of the young readers of this YN Corner find something very unusual in circulation, please contact me. I would like to share your find with the other searchers.

Sheheen, Jr. Young Numismatist Scholarship! The winners are Miss Shelby Plooster, from Evans, Georgia, and Mr. Andrew Grischuk, from Conway, South Carolina. Each winner will receive \$2000.00 to be used for one week's tuition to the American Numismatic Association (ANA) Summer Seminar in Colorado Springs, Colorado and airfare. The ANA Summer Seminar has two one-week sessions with a large assortment of courses taught by some of the foremost experts in their field. Additional sight-seeing tours (such as the Denver Mint) are also available during the week for participants. Since 1986 the United States government has been producing gold coins (non-circulating legal tender), uncirculated and proof, for people who wanted to own gold bullion in a convenient form. These coins are the 1/10 ounce gold Eagle (\$5.00), ¼ ounce gold Eagle (\$10.00), 1/2 ounce gold Eagle (\$25.00), and one ounce gold Eagle (\$50.00). Starting in 2006, the 1 ounce gold Buffalo (\$50) has been in production, too. The actual value of these coins is generally tied to the market value of the gold weight.

Before you decide to purchase any gold coin it is important to know what you are buying. You need to do your homework on gold coins before you decide to buy. Gold coins have been counterfeited about as long as gold coins have been made. Consider purchasing certified or encapsulated (“slabbed”) coins. Since the market value of gold changes daily you need to know the current price of gold when you are ready to buy. If you are interested in rare gold coins expect to pay much more than the gold market value.

Are you making plans for the 2014 SCNA State Convention in Greenville, South Carolina? This year’s convention is expected to have over 100 tables of numismatic items; there will be an YN Table for the young collectors; the YN Exhibition Program has improved the awards for the winners; and there will be a free Saturday YN education program with fun surprises for all.

The 7 Die States of the 1926-S Peace Dollar VAM 4 Dr. David Close

There are several popular Morgan VAM varieties which are collected by die state, the most notable of these are the 1887 "Scarface" & the 1921-S "Thornhead". In the Peace dollars, the Top 50 1992 VAM 7 has two known obverses paired with the doubled die reverse, known as VAM 7A & VAM 7B respectively.

In my study of the 1926-S VAM 4, I had noticed early on that there were two different obverses paired with this Top 50 reverse. As I studied this variety in more detail, I have found seven distinct die states, with the possibility that at least one more exists but has not yet been found....at least not by me!

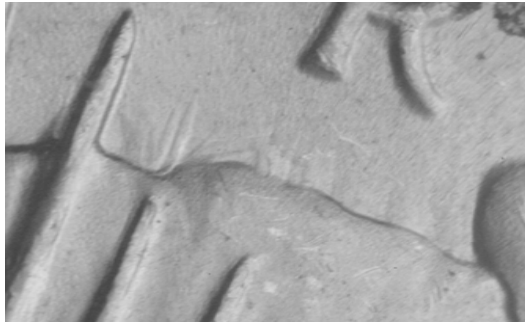

Terminology

Die Clashes are errors that happen when the coin dies come together in the coining press without a planchet between them. This causes an imprint of each die to be left on the opposing die face. For example, an impression of the obverse die is left on the reverse die, and vice versa.

Die Polishing is the process of cleaning the dies used to strike a coin. Over the course of the life of a working die, dirt and grime may accumulate on the die itself. In addition, the die may acquire clash marks or other imperfections that a mint worker might try to *polish* away in an attempt to strike "cleaner" coins.

Die Scratches are raised lines which appear on a coin as a result of scratches on the die used to strike that coin.

Die Cracks are raised lines which appear on a coin as a result of that coin having been struck by a cracked die.

Die Chips A small piece (less than 4 square millimeters) that falls out of the die face and has no direct connection to the design rim. The missing piece leaves a void in the die face into which coin metal flows. As a result, the coin shows a featureless lump in the affected area.

The Best Secured Coin Shows for 2013

Clifton, Virginia—Colonel Steven Ellsworth of the Butternut Company has announced the annual selection of “The Best Secured Coin Shows for year 2013.” COL Ellsworth has personally attended nearly 40 coin shows and conventions during 2013 where he pays particular attention and evaluates the various types of security that are provided to both dealers and the public. In addition, he receives numerous reports from across the nation from coin dealers, collectors, and crime-incident reports from the media and law enforcement sources. This is the 17th year a report and a list has been named.

“Last year in my report I predicted that due to our near stagnate economy crimes perpetrated by criminals would escalate and unfortunately this has come to fruition” COL Ellsworth stated. During 2013 we had several violent home invasions and robberies of coin collectors and dealers, several at gunpoint. Along with these violent crimes we still had nearly one a month of road-side thefts and robberies. In addition we had several armed robberies and assaults that resulted in several in-store shootings. Some may have occurred due to dealer/collector lapses or lack of their own security procedures, but some are for economic gain or in supporting illicit drug activities.

Our 2014 economy will likely be a repeat for criminal endeavors. We are all very lucrative targets for the criminal, especially since our hobby is advertised in so many local publications, as well as road signs offering to buy gold and coins. "As predicted several dealers and collectors were virtually wiped-out and have terminated their business's with some collectors quitting the hobby," reported COL Ellsworth.

In response more and more dealers and collectors have rushed out and purchased a gun(s) and applied for a concealed weapon permit (CCW) for their state. Most have done so without any thought to serious education and training. As a *Advanced Certified NRA Instructor* I would advise against this approach. Unless the individual involved is committed to continuous firearm instruction and training they are not only putting themselves at risk, but those around them. Many of us took a driving class at 15 or 16 years old in order to get our drivers license. Then many made the mistake that we were "good for life". Unfortunately concept costs countless thousands of highway deaths each year. Owning and carrying a firearm requires even more responsibility and a commitment than driving a car. It requires continuous serious instruction and training to maintain proficiency. This is not accomplished by "a friend who is a cop", or "my neighbor was in the military" taking you out and punching holes in paper or shooting at bottles.

]

It is only accomplished by proper training from a professional firearms instructors. Like in sports such as tennis or golf, shooting is a perishable skill. But unlike a sport where errors cost you the game, errors in shooting could cost you a legal nightmare or even a life. Unless you are willing to take the time and spend the money for training, I would advise not making a firearm part of your security plan.

Recognizing this dilemma, the American Numismatic Association has made a bold proactive step by offering an in-depth 4-day security course during their Colorado Springs, Summer Seminar Sessions. The course was titled *"Think Like A Thief: Security for Dealers and Collectors"*. The course will be taught by Doug Davis of Numismatic Crime Information Center, Sgt. Scott Morgan a Pima County Deputy Sheriff and COL Steven Ellsworth, ret. The course walks through development of a Security Plan or reviews and updates existing plans. This course fills the proficiency requirements for most states CCW permits. I would highly recommend it for dealers and for firms to send a representative. In addition, Doug Davis continues to give seminars to Federal, State, County and Local law enforcement officers and how better to investigate numismatic crimes. As I have continuously advised for over 20 years, the single greatest risk to a dealer or collector is after a show. It does not matter if you are loading your vehicle at the convention site or being followed while on the road, you have been observed and possible targeted by thieves or been singled out by random opportunity criminals. Dealers or collectors should never leave their coins in an unintended vehicle, this is rule number one. If this simple rule is not written in your own security plan, then you are giving an open invitation to being a victim of a crime. "Why is it that this concept so difficult to grasp and is seldom followed by so many victims of theft? And importantly, a plan that is not written is only an idea. Defiantly a mistake as to your own safety and security" Ellsworth lamented.

Very few dealers and even fewer collectors spend the time and money needed to actually minimize the risks associated with our hobby, and even fewer take the effort to train for it. It is important to realize that security is an individual's own responsibility and not that of a show promoter, sponsors, the police or government. It is up to every dealer and serious collector to have a written plan on how they will handle the array of security threats. Many dealers tell me they are real careful when they are transporting coins. To which I ask, what is your plan if this or that threat occurs?

]

In nearly all cases they have not thought that far ahead and have no idea what they will do. Their plan they say will evolve by their SOP (seat of the pants) but in reality they most likely will be like a deer in the headlights if they are confronted with a theft. The usual response afterwards is "I could not believe this was happening to me".

All shows listed below were actually attended by our company or our representative. Our list is slightly smaller this year. More shows and promoters are taking the safety of the exhibitors and attendees more seriously, but most still do not prosecute shoplifters. Simply throwing a shoplifter out of a show creates an incentive to repeat their crimes and for others to follow suit. It is time consuming and expensive however, dealers and bourse chairs must take on the burden to prosecute an offender. And as a final note; in your security personnel briefing, advise them to stay off their I-phones and cell phones when working and to limit use only for must answer calls. It is impossible for them to be texting and still be vigilant to the security task at hand. In alphabetical order, these are the **"The Best of the Best in Coin Show Security for 2013"**. Our only objective is always to keep security matters on the "front burner" to help dealers and collectors manage the risks posed from theft or worse" said Colonel Steven Ellsworth

American Numismatic Association Worlds Fair of Money Show,
Chicago, IL. (Previously named in years past)

They do it right. Security was continually provided by uniformed Police and plain clothes private security. Security was provided in and out of the facility during set up and breakdown. All security officers are tied into a monitored communication net. Registration and name tags were required for all attendees. The ANA staff and board is given special recognition this year for their proactive efforts to reduce crime and improve the safety of its members and staff and the entire hobby through their continued educational efforts. Much has gone on behind the scenes that the public may never know or see but the efforts of the ANA are beginning to take effect. Never in the previous 110 years of its existence has the ANA actively done more to increase the awareness and education to help reduce the threat of crime as this organization has and deserves to be commended.

The show is at a new location and security adjusted quickly to the changed venue. Security is continually provided by a private security firm and several off-duty law enforcement. Security is provided in and out of the facility during set up and breakdown. Unloading and Loading is under watchful eyes of security personnel. Security personnel continually walk the show floor to discourage shoplifting. All security officers are tied into a monitored communication net. A registration fee and nametags were required for all attendees.

Blue Ridge Numismatic Association, Dalton, GA. (Previously named in years past) Security is continually provided by off-duty uniformed Walker County Sheriffs, off duty GBI agents & private security. Security is provided in and out of the facility during set up and breakdown. Unloading and Loading is under watchful eyes of security personnel. Security personnel continually walk the show floor to discourage shoplifting. Registration and nametags were required for all attendees.

Florida United Numismatist Convention, Orlando, FL (Previously named in years past) Security is provided by a private security contractor and supplemented by numerous off-duty uniformed Orange County police. Security is vigilant in and out of the facility during set up and breakdown. Security is triple layered with uniformed, plain clothes and video surveillance. Parking areas are also patrolled before, during and following the show. Registration and nametags are required for all attendees. As one of the largest shows in the country, they always set a good example. The amount of resources devoted for security at this show is impressive.

Georgia State Numismatic Association, Dalton, GA. (Previously named in years past) Security is continual provided by off-duty uniformed Walker County Sheriffs, off duty GBI agents and private security. Security is provided in and out of the facility during set up and breakdown. Unloading and Loading is under watchful security personnel. Security personnel continually walk the show floor to discourage shoplifting. Registration and nametags are required for all attendees.

Pennsylvania Association of Numismatists (PAN), Monroeville, PA.
(Previously named in years past) Security is provided by a private security firm wearing distinctive company clothing of armed personnel. Security is provided in and out of the facility during set up and breakdown. Registration and nametags were required for all attendees. Unloading and Loading is under watchful eyes of security personnel. As with all shows, collectors and dealers leaving the watchful eyes of show security must immediately implement their own individual plan on their remaining travel to avoid theft.

Texas Numismatic Association, Fort Worth, TX Security is provided by Doug Davis of Numismatic Crime Information Center and off duty Fort Worth Sheriff Deputies. Security is excellent from setup to breakdown with both uniform and plain clothes officers keeping constant vigilance of the bourse, parking areas, entrances and exits of the facility. Officers are well equipped with all the necessary weapons and equipment to handle most any incident. Registration and nametags are required for all attendees.

South Carolina State Show, Greenville, SC. (Previously named in years past). Security is provided by South Carolina Constables and retired South Carolina State Troopers. Security is vigilant in and out of the facility during set up and breakdown and is continuous during the show. Officers are equipped with additional assault weapons and equipment at night. Registration and nametags are required for all attendees.

Virginia Beach Coin Show, Virginia Beach, VA. (Previously named in years past). Security is continually provided by uniformed Virginia Beach Police. Unloading and loading of the convention center is observed by a police presence and provides better than average security for dealers un-loading and loading. Several of the officers are instructors at nearby Academe (formally Blackwater) where security is a religion. Registration and nametags are required for all attendees.

Weyers Cave, VA. (Previously named in years past). Security is provided by off-duty plain clothes Augusta County Sheriff's deputies. Even though it is a small show with just 40 tables, two officers are present during the show and during setup and breakdown. Law enforcement personnel continually monitor the entrances, loading and parking areas. It is noteworthy that even in small shows, security can be taken seriously.

Whitman Baltimore Coin & Currency Convention, Baltimore, MD. (Previously named in years past). Security is continually provided by private security and uniformed Baltimore City Police. Unloading and loading is in a gated section of the convention center and provides better than average security for dealers un-loading and loading. All security officers are tied into a monitored communication net. Registration and nametags are required for all attendees. This show has grown to one the largest in the country and their security has adjusted accordingly.

COL Steven Ellsworth is a retired Army Colonel with over 32 years of service. His many assignments include serving in the Army's elite Rangers and Special Forces (Green Berets) and in addition he has had assignments as a Physical, Intelligence and Communication Security Inspector. He has received highly specialized training in anti-terrorist, physical, intelligence and personal protective security. He currently is a full time coin dealer and a collector and serves on several numismatic boards. He is a master certified NRA instructor and has been an instructor for the American Numismatic Association during the Summer Seminar in Colorado Springs numerous times over the last 15 years.

Colonel Ellsworth has written many articles on coin collector security over the last twenty years. - Each exhibitor must submit a separate application for each category or class of exhibits being entered. Exhibitors must be a member of the SCNA.
- The exhibit application(s) must reach the address of the responsible person on the application by the date specified.
- SCNA officers, judges of exhibits, or their families shall not place judged exhibits. Non-competitive exhibits are permitted for these persons.
- All materials in exhibits must be authentic. Any replicas, forgeries, or counterfeit materials must be labeled as such.
- Exhibits may not advertise any contents for sale or have any statement of price or value. There will be no identification as to ownership or reference to the person displaying the material submitted for display.
- Up to 4 exhibit cases may be provided by the SCNA to exhibitors for use at the convention. Exhibitors may use their own cases provided total space does not exceed space of 4 SCNA cases.
- All cases must lie flat on the tables provided.
- No electrical outlets will be provided.
- No titles or placards or numismatic material of any kind may be placed outside the exhibit cases.
- Exhibits of material not capable of being presented in the usual cases will be permitted only upon prior and specific arrangement with the exhibit chairperson and subject to the concurrence of the executive board chairperson (President).
- In the event of any question of the legality of any material submitted for display, the decision of the SCNA President or the show exhibit chairperson is final.
- Exhibit rooms will be open for the placement of exhibits according to the time schedule set on the application or in the letter accompanying it. Each exhibitor is responsible for having his/her exhibit set up at the appointed time.
- A small label will be affixed to each case denoting the number of the exhibit, the number of cases, and the group (category) in which it is entered.
- The Exhibit chairperson will keep a full and complete record of all exhibits, showing the name of the exhibitor, the group (category), the ID number, and number of cases used. Names of the exhibitor will not be disclosed until the judges have made their reports to the chief judge, all reports are tallied and prepared, and winners and runner-up(s) have been determined. Exhibitors who wish to remain anonymous must inform the exhibits chairperson with the application.
- Each SCNA display case will remain locked and sealed by the exhibit chairperson or assistant in the presence of the exhibitor. (The exhibit chairperson will keep the case keys until the exhibits are removed; or, the cases shall be locked and the keys shall be the responsibility of the exhibitor until the exhibit is removed.)
- Security will be provided during the show times published. Exhibitors are advised the presence of security personnel or security systems do not constitute a guarantee against loss, a policy of insurance, or a promise to indemnify in the event of loss by fire, theft or other casualty.
- To be considered for an award the exhibit must be in the exhibit hall prior to the deadline set forth previously mentioned according to the time stated in the application letter.
- The decision of the exhibit judges is final. The award will be presented at a scheduled ceremony scheduled by the SCNA President and the board members.
