Tables may not be transferred, sold, or shared without the consent of the Bourse Chairman. **NO REFUND for the cancellation of a table after thirty (30) days prior to show starting date.** The Bourse Chairman must be notified if a dealer is not expected to show up on the first day of the show. Any dealer not arriving by the first day of the show and who has not notified the Bourse Chairman will forfeit his table and \$100 deposit. **\$100.00 MINIMUM DEPOSIT - BALANCE MUST BE PAID BY OCTOBER 1, 2019.** Also, please note that there are limited number of corner tables available for \$500.00. Corner tables include two 8-foot tables and one backup table. **Every dealer must be an SCNA member and have a separate bourse application on file, even when sharing tables.**
